## ACTIVITIES ACCOMPLISHED DURING THE YEAR

### A. KUSAL YUVA PROGRAM(KYP)

*Kusal Yuva Program was initiated by Bihar Skill Development Mission, Government of Bihar in the year 2016 under the Seven Nishchay Program by the Bihar Government. Under this program, the government took a resolution to establish skill development centers in all the blocks of all the districts of Bihar. Under which, after selection and after getting work award Srishti International is running the skill development center in Sampatchak block for the last 7 years, which is running at its designated place. Kusal Yuva Program is an ambitious program of the Government, in which online training is imparted to students aged between 15 to 28 years. Under the Kusal Yuva Programme, students are given online training, where their biometric retina attendance are captured before the commencement of daily online training which comprises of theory as well as practical classes. Under the Kusal Yuva Programme, students are given training in information technology, language skills and soft skills. To join program, students are required to have passed 10th as per the norms.*

- As per the guidelines of BSDM, each candidate desirous to get trained under KYP needs to deposit security money of Rs. One thousand which is refunded to their after successful completion of the course.
- At our SDC, we pay Rs.500.00 to each successful candidate as reward apart from the security money which get refunded by BSDM to their bank account.
- Number of students enrolled in our Skill Development Center in the year 2023-2024 is 243. For the enrollment of those 243 students, the organization had transferred security deposit amount of ₹ 2,43,000.00 to the Bihar Skill Development Mission, Government of Bihar. Students receive it back in their bank account. The students undergoing training in our institute are given breakfast at the rate of ₹ 20 per student per day, which is not done in any other institute.
- In Kushal Yuva Program, we provide training to the students for 4 hours every day, in which we provide computer training in the first hour of theory and next hour practical under which they get fundamental computer training like Paint, Notepad, Wordpad, Microsoft Office, Microsoft Excel, Microsoft PowerPoint, Internet etc. This training is of 2 hours daily. In which we provide them training in theoretical and practical classes as per the training module prescribed by the government.



#### **PRACTICAL CLASSES IS BEING CONDUCTED IN THE COMPUTER LABORATORY**

During the online classroom session, students get questions online which they have to answer in the same classroom, which we call classroom clicker. The score of that question is added to the score of their final exam result. After the classroom, students go to the lab which we call lab session, where they answer 40 questions online from the syllabus of classroom session. After the lab is done, we take it back to class, Where we give them online classes on either language skills or soft skills, in which they learn speaking, listening, understanding, reading and writing in English and Hindi, vocabulary, sentence formation, grammar, pronunciation, quality of communication, communication The medium etc. is described by the Video module, And in soft skills, we train them in behavioral skills. During the video class, there are questions asked to the students which they have answer there itself. After this class, we take them to the lab, where again they have answer 20 questions in the lab which is completely online; Whose score is added to their final exam score.


